Subject: Consideration of compliance verification assessment report with regard to Continuance of recognition of MBBS degree granted by Chettinad Academy of Research and Education (Deemed University), Chettinad in respect of students being trained at Chettinad Hospital & Research Institute, Kanchipuram - Reg.

Sir/Madam,

I am directed to inform that the compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Chettinad Academy of Research and Education (Deemed University), Chettinad in respect of students being trained at Chettinad Hospital & Research Institute. Kanchipuram was carried out by the Council assessors' on 1st June, 2018. The said assessment report along with previous reports (2nd April, 2018, 31st July 2017 &1st August, 2017) was considered by the Executive Committee at its meeting held on 05.06.2018 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (1st June, 2018) along with previous reports (2nd April, 2018, 31st July 2017 & 1st August, 2017) and decided to revoke the decision of application of clause 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment). 2010(Part II). dated 16th April, 2010.

The Executive Committee further recommended that recognition of MBBS degree granted by Chettinad Academy of Research and Education (Deemed University). Chettinad in respect of students being trained at Chettinad Hospital & Research Institute, Kanchipuram be continued restricting the number of admissions to 150 (One Hundred Fifty) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 12.06.2018.
