Extract of the resolution of the Council

“The Tamil Nadu Nurses and Midwives Council having satisfied itself with the infrastructure available in **Chettinad College of Nursing under Chettinad Academy of Research and Education (Deemed to be University), Kancheepuram** as pointed out in the Primary/Statutory inspection report and in exercise of the powers vested with the Council under rule 37 of the rules made under Section 11(2) (c) of the Tamil Nadu Nurses and Midwives Act (Act III) 1926 resolves to grant Provisional Recognition to the above said institution to conduct the first year M.Sc.,Nursing Programme for the **academic year 2018-2019 only with an annual intake of not exceeding 10 students (ie: 2 in each speciality)** & Continuance of Provisional Recognition to the following programmes subject to the following conditions:

3.	P.B.B.Sc.,(N)	2018-2019	50

1. Do not admit underage & overage students.
2. Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2018-2019 and admission must be made only once a year.
3. Fresh batch of admission of students is permitted for 2018-2019 only.
4. Every year list of candidates admitted during the year together with their age and qualification to be uploaded **in the Council's Institutional Management Software (I.M.S.)** for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
5. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.

6. Failure to maintain the prescribed requirements will result in de-recognition.
7. Inspection will be arranged by this Council before starting II-batch of programme in 2019-2020 under Rule (38) of the rules framed under section 11 (2) (c) of the Tamil Nadu Nurses and Midwives Act III of 1926 **and students should be admitted for II year afterwards only.**
8. **This Provisional Recognition of Tamil Nadu Nurses and Midwives Council is subject to affiliation of concerned University for the academic session 2018-2019 and conduct of statutory inspection of Indian Nursing Council, New Delhi vide INC-F.No:1-6/2018-INC dated 16.04.2018 & No:F.No:1-6/2018-INC dated 20.04.2018.**
9. The institution shall have to abide by the guidelines/instructions/regulations issued by Tamil Nadu Nurses and Midwives Council, State Government / Indian Nursing Council, New Delhi from time to time.
10. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
11. If at any time the institution will found un-suitable, the recognition will be withdrawn forthwith by Indian Nursing Council, New Delhi/Tamil Nadu Nurses and Midwives Council
12. **Recognition fee of Rs.15,000/- for M.Sc.,(N), Rs.10,000/- for B.Sc.,(N) & Rs.10,000/-for Post Basic B.Sc.,(N) in the form of Demand Draft favouring Registrar, Tamil Nadu Nurses and Midwives Council, Chennai-4 must be paid every year by 30th June.**
13. **Council Prescribed Uniform for Clinical for the students should be strictly adhered.**
14. All the correspondence should be done by the Principal only.
