V Admission Procedure

Eligibility for admission to M.B.B.S. degree course:

a) Age Requirements:

 Candidates should have completed 17 years of age at the time of admission or will complete that age on or before December 31, 2024. The candidates must be born on or before 31,12,2007.

b) NEET-UG 2024 Performance:

• Candidates must have appeared for the NEET-UG 2024 and must have a rank in the merit list of NEET-UG 2024 for admission to MBBS Course.

c) Qualifying Percentile & Score Range:

d) Academic Qualifications:

Candidates should have passed 10+2 Education or its equivalent with PCB/BT and English obtained the minimum percentage of marks in the qualifying examination as per the norms of the National Medical Commission, New Delhi.

- Candidates must have passed Physics, Chemistry, Biology/Biotechnology, and English individually.
- A minimum 50% of marks is required in aggregate of Physics, Chemistry, and Biology/Biotechnology.
- For SC/ST/OBC candidates, the aggregate requirement is 40%.

- Candidates with benchmark disabilities need a minimum aggregate of 45%, in compliance with the Rights of Persons with Disabilities Act, 2016.
- Must have a rank in the Merit list of NEET-UG 2024 for admission to MBBS course.

e) Selection Process:

 Admission will be granted based on NEET-UG 2024 scores within the respective categories.

f) Additional Information:

- There shall be no reservation for OBC/SC/ST/PWD/EWS candidates in deemed to be universities as per MCC.
- For all other eligibility conditions, the website of the National Medical Commission,
 New Delhi may be referred.

Counseling Process by MCC:

- National Counseling: All 100% of seats of deemed universities will be filled through National-level online counseling by the Medical Counseling Committee (MCC) of DGHS, New Delhi.
- **Counseling Rounds:** There are four rounds Round 1, Round 2, Mopup Round, and Stray Vacancy Round. All rounds will be conducted through online by the MCC as per schedule of counseling.
- **Registration:** To become eligible for allotment of a seat, candidates are required to register on the MCC website: www.mcc.nic.in. Keep checking the site for updates and counseling schedules.

After Allotment:

- Reporting: Candidates after getting an online provisional allotment order from MCC, must report to the Institute along with the order. Pay the entire tuition and other fees for the year 2024-25 by the due date mentioned in the order.
- **Documents:** Candidates must bring all original certificates to the institute. Make sure to have photocopies for your records.

The amount of fee to be deducted in case candidate resigns after counseling period / cutoff date:

Where any student applies for discontinuance, or without any application discontinues on his/her own, from the course to which he/she has been admitted to, for any reason, either on or after the cut-off date prescribed by the statutory and/or University authorities for admission to the first year of the course or where the seat is rendered vacant without having any chance of being filled up with any other candidate such students will have to remit the tuition fee and other applicable fees for the 'entire/ remaining duration of course period'.

IX General Information:

- Your admission is based on meeting the eligibility and health requirements set by the authorities.
- If you provide false information or fake documents, your admission will be cancelled, fees will not be returned, and you could face legal action.
- If you receive a provisional allotment letter, please submit all required documents to the institute along with payment of fees within the scheduled time. Don't wait until the last minute, as document verification and admission processes take time.
- You must report in person on the date and time given by the MCC in your allotment order. Bring all original documents and make sure your tuition fee payment is complete.
- If your original documents are with another institution, you need to retrieve them. Admission will not be completed if you only bring a certificate stating your documents are elsewhere.
- Once admitted, you must follow the university's rules regarding the syllabus, exams, fees, and conduct.
- The university can change any rules to comply with official regulations from time to time.
- Once admitted to this Institution no student shall be allowed to seek transfer/migration to any other Medical Institution within or outside the state under any circumstances.
- You must pay all tuition and other fees by the due dates in the coming years. If you don't, your name will be removed from the college rolls.
- You must be present yourself for counseling and admission. No one else can represent you.
- Any disputes about these rules will be decided by the Vice Chancellor, and their decision is final.

- Legal matters related to this bulletin / prospectus will be handled in Chennai only.
- Try not to take long leave and aim to finish your course on time. No student shall be allowed to continue MBBS course after nine (09) years from the date of admission into the course.
- Your name and date of birth will be registered as in your certificate of qualifying exam passed. No changes will be allowed later, so check these details carefully during admission.

Anti-Ragging Policy:

• Ragging is strictly banned and is a punishable crime. The university follows strict rules to prevent ragging, in line with national regulations.

Break of Study:

• In case of students encounter an interruption in their studies for any reason, they are required to remit the prescribed 'Break Fee' to the institution upon their re-admission, subject to the issue of a condonation order by the University.

Compulsory Rotating Medical Internship (CRMI):

- **Mandatory Internship:** After you pass the final MBBS Part II exam, candidates must do a 12-month medical internship. This is a key part of your training.
- **Flexible Duration:** If needed, this duration will be extended appropriately by a reasonable period on recommendation by the college or university.
- **Completion Time:** Candidates should complete the twelve months period of internship within two years of passing final MBBS part II examination.
- **No CRMI Transfer:** The candidates shall complete their entire period of CRMI training at CHRI where they have pursued and completed their MBBS degree course.
