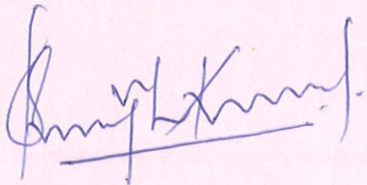
Agenda 2: To organize a Career Guidance Program for Physiotherapy Students
