### Minutes of the Meeting

1. At the beginning of every academic year, orientation programmes will be conducted for newly admitted as well as senior students across all streams. The Dean, faculty members, wardens, and administrators will address the students and emphasize the importance of maintaining a ragging-free campus.
2. During these orientation sessions, it should be highlighted that any student found involved in ragging will face immediate suspension from the college and hostel, and will be subject to disciplinary action as per the decision of the Anti-Ragging Committee.
3. Students must be clearly informed that ragging in any form is strictly prohibited within the campus and hostel premises. They should refrain from indulging in such activities under any circumstances.
4. Regular awareness meetings shall be organized to sensitize students, advising them to regulate their movements and interactions, particularly with strangers.
5. All members are requested to remain vigilant and ensure prevention of ragging in and around the campus. Any untoward incident, if noticed, must be reported immediately to the Convener.
