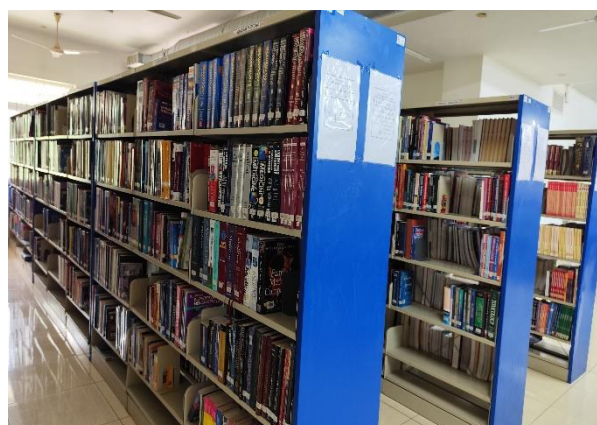

V Admission Procedure

1. Eligibility for admission to M.B.B.S. degree course:

a) Age Requirement:

- Candidates should have completed 17 years of age at the time of admission or will complete that age on or before December 31, 2026. The candidates must be born on or before 31.12.2009.

b) NEET-UG 2026 Performance:

Candidates must have appeared for the NEET-UG 2026 and must have a eligible rank in the merit list of NEET-UG 2026 for admission to MBBS Course.

c) Qualifying Percentile & Score Range: [NEET UG 2026]

d) Academic Qualifications:

Candidates should have passed 10+2 Education or its equivalent with subjects PCB/BT and English obtained the minimum percentage of marks in the qualifying examination as per the norms of the National Medical Commission, New Delhi.

- Candidates must have passed Physics, Chemistry, Biology/Biotechnology, and English individually.
- A minimum 50% of marks is required in aggregate of Physics, Chemistry, and Biology/Biotechnology.
- For SC/ST/OBC candidates, the aggregate requirement is 40%.
- Candidates with benchmark disabilities need a minimum aggregate of 45%, in compliance with the Rights of Persons with Disabilities Act, 2016.
- Must have a rank in the Merit list of NEET-UG 2026 for admission to MBBS course.

2.Selection and Counseling Process by MCC:

- Admission will be granted based on NEET-UG 2026 scores within the respective categories.
- **National Counseling:** All 100% of seats of deemed universities will be filled through National-level online counseling by the Medical Counseling Committee (MCC) of DGHS, New Delhi.
- **Counseling Rounds:** There are four rounds - Round 1, Round 2, Round 3 and Stray Vacancy Round.
- **Registration:** To become eligible for allotment of a seat, candidates are required to register on the MCC website: www.mcc.nic.in. Keep checking the site for updates and counseling schedules.
- There shall be no reservation for OBC/SC/ST/PWD/EWS candidates in deemed to be universities as per MCC.
- For all other eligibility conditions, the website of the National Medical Commission, New Delhi may be referred.

3.After Allotment:

- **Reporting:** Candidates after getting an online provisional allotment order from MCC, must report to the Institute along with the order and all the original certificates. Pay the entire tuition and other fees for the year 2026-27 by the due date mentioned in the order.
- **Documents:** Candidates must bring all original certificates to the institute. Make sure to have photocopies for Candidate's records.

VI Details of M.B.B.S. seats and payment of fees for 2026-27

Course Duration, Annual intake, Tuition fee and other Fees:

Duration of the MBBS Course : 5 ½ Years [Five and Half Year]

a) Academic Study : 4.5 years of rigorous classroom study and clinical training

b) Compulsory Rotating Medical

Internship(CRMI): 1 year Medical Internship with paid stipend in the Teaching Hospital attached to the institution.

Annual intake: 100 seats

Tuition fees:

The students are required to pay the tuition fee for 4 ½ years only. No tuition fee is payable towards the 1-year internship / CRMI training.

The total tuition fee payable by any student admitted for MBBS program in this institute is Rs. 1,00,00,000 (Rupees One Crore only). The total tuition fee for 4 ½ Years shall be payable by each student either partly as divided into 4 ½ parts in the manner specified in Table No.1 (OR) in Five (5) equal Parts in the manner specified in Table No.2 below:

*** The Tuition fee mentioned in 4th Part and 5th Part of Table No.2 includes the fees payable towards the Phase 3 (Part 2) of 1 ½ Year academic study which is divided as 12 Months (4th Part) and 6 Months (5th Part). Though the option given in Table 2 appears that the tuition fee collected for the first 6 months in the 5th year seems to be the same 20 lakhs like the previous 4 years, the student actually pays only Rs.11,11,111 for 6 months and the remaining Rs.8,88,888 pending from the previous 4 years (Rs.2,22,222 x 4 years).

No Tuition Fee is payable for the CRMI period (One Year) which commences at the completion of 4 ½ years of academic study and expires at the end of 5 ½ years.

Discontinuance:

The amount of fee to be deducted in case candidate resigns after counseling period / cutoff date:

Where any student applies for discontinuance, or without any application discontinues on his/her own, from the course to which he/she has been admitted to, for any reason, either on or after the cut-off date prescribed by the statutory and/or University authorities for admission to the first year of the course or where the seat is rendered vacant without having any chance of being filled up with any other candidate such student will have to remit the tuition and other applicable fees for the 'entire/ remaining duration of course period'.

IX General Information:

- All eligible applicant for the sessions 2026-27 must familiarize themselves with the contents of this Information bulletin, MCC and NMC norms regarding admission to MBBS course.
- Your admission is based on meeting the eligibility and health requirements set by the authorities.
- If you provide false information or fake documents, your admission will be cancelled, fees will not be returned, and you could face legal action.
- If you receive a provisional allotment letter at CIMER, please submit all required documents to the institute along with payment of fees within the scheduled time. Don't wait until the last minute, as document verification and admission processes take time.
- You must report in person on the date and time given by the MCC in your allotment order. Bring all original documents and make sure your tuition fee payment is complete.

- If your original documents are with another institution, you need to retrieve them. Admission will not be completed if you only bring a certificate stating your documents are elsewhere.
- Once admitted, you must follow the university's rules regarding the syllabus, exams, fees, and conduct.
- The university can change any rules to comply with official regulations from time to time.
- Once admitted to this Institution no student shall be allowed to seek transfer/migration to any other Medical Institution within or outside the state under any circumstances.
- Students are required to pay the prescribed tuition fees and all other applicable fees on or before the stipulated due dates each academic year. Failure to comply with the fee payment schedule may result in the removal of the student's name from the college rolls, in accordance with the University's rules and regulations.
- You must be present yourself for counseling and admission. No one else can represent you.
- Any disputes about these rules will be decided by the Vice Chancellor, and his decision is final.
- The medium of teaching and Examination shall be English.
- Under no circumstances the student shall be allowed more than four (04) attempts for first year (First Professional MBBS). The total period for successful completion of Phase I course shall not exceed four (04) years. The student shall not be entitled to graduate later than ten (10) years of joining the first MBBS course (including continuous rotatory Medical internship), as per the norms by the NMC.
- Your name and date of birth will be registered as in your certificate of qualifying exam passed. No changes will be allowed later, so check these details carefully during admission.
- Try not to take long leave and aim to finish your course on time
- Legal matters related to this bulletin will be handled in Chennai only.

Anti-Ragging Policy:

- Ragging is strictly banned and is a punishable crime. The university follows strict rules to prevent ragging, in line with national regulations.

Break Fee:

- In case if the study period of student is extended for whatsoever reasons, such instance will be categorized as a break of study. Accordingly, break fee will be applicable for the extended duration beyond originally scheduled in accordance with the fees structure laid down by the University from time to time.

Compulsory Rotating Medical Internship (CRMI):

- **Mandatory Internship:** After passing the final MBBS Part II exam, candidates must do a 12-month internship. This is a key part of MBBS training.
- **Flexible Duration:** If needed, this duration will be extended appropriately by a reasonable period on recommendation by the college or university.
- **Completion Time:** Candidates should complete the twelve months period of internship within two years of passing final MBBS part II examination.
- **No CRMI Transfer:** Transfer of CRMI training to any other hospital is not permissible.
